Non-Member Rental Fees:

- 1. Non-member rental fees for the Social Hall will be charged a fee of \$100.00 with use of the kitchen for a minimum of 4 hours.
- 2. Churches located in Hughesville using the Social Hall for banquets, the fee will be \$100.00
- 3. Non-members using the Sanctuary for weddings will be responsible for removal of decorations and restoring the edifice to proper order. The fee for use of the Sanctuary is \$100.00.

Non-Active Member Rental Fees:

1. Non-active members will be charged a fee of \$50 for use of the Social Hall or Sanctuary.

Member Privileges:

- 1. No rental fee will be charged to active members using the Social Hall for wedding receptions, wedding anniversary celebrations, birthday celebrations, or family gatherings (donations will be acceptable).
- 2. The regular rental fees will apply to active members using the Social Hall for any business purposes. (\$100)

Rules and Regulations For Use of Social Hall and Church:

- 1. No alcoholic beverages on Church premises, including Social Hall.
- 2. No smoking permitted in the Church or Social Hall.
- 3. The Social Hall may be used with no charge, the evening before to decorate (if no other engagements are scheduled).
- 4. Decorating of the Social Hall will be restricted to tables and Scotch tape only. No tacks or nails in wood-work or walls.
- 5. Decorations (including tape) must be removed within 24 hours or sooner if another engagement is scheduled.
- 6. There will be no decorations permitted in the Church Sanctuary other than those used for weddings (flowers, pew ribbons for reserved seats, etc.). (The usual Christmas decorations, etc.).

- 7. Anyone using Social Hall refrigerators *must* remove all their food.
- 8. Anyone using kitchen facilities are responsible for cleaning the dishes, pans, coffee pots, floors and linens.
- 9. All garbage <u>must</u> be removed from the building following each event. Garbage <u>must</u> be taken by users to a proper receptacle. <u>Please do not place in our garbage can.</u>
- 10. All tables used <u>must</u> be cleaned before leaving.
- 11. The furniture and equipment shall not be taken from the Social Hall without the permission of the Board of Trustees. Such permission will be granted to members only.
- 12. The Board of Trustees shall make all decisions regarding the rental and use of the Social Hall and the Church Sanctuary and the large Sunday School room.
- 13. All classes, church organizations, etc. using the Social Hall must call the church office and have it put on the Church calendar, which will be put on the bulletin board.
- 14. All equipment loaned from the church must be inventoried and signed out by the Chairman of the House Committee who will follow up on the prompt return of same.
- 15. Any room used *must* be in same condition as when users arrived.
- 16. A minimum \$50 cleaning fee will be added if the Sanctuary, Social Hall or any other room used is not cleaned and put back together before leaving.
