The New York Public Service Commission (NYPSC) recently approved \$701 million in electric vehicle service equipment (EVSE) Make-Ready funding, with the goal of placing 55,000 new EV charging stations across the state – 1,500 of them being DC fast chargers (DCFC). Want to see how much you can save?



Understanding the **program**

Transportation has long been one of the leading causes of greenhouse gases in New York State. To achieve their ambitious goal of net-zero emissions by 2050, catalyzing the adoption of EVs is crucial. That is why Gov. Cuomo has announced a package of major clean transportation initiatives to kickstart EV adoption across the state, including the “Make-Ready” order approved by the NYPSC.

The “first truly major initiative to develop EV infrastructure at scale” (John Howard, Commissioner NYPSC), this new program is designed to make it easier than ever for locations in New York to realize their EV charging aspirations by providing funding for the make-ready costs of their project.

What is **EV** make-ready



“EV Make-Ready” is the process when a location is prepared for an EV charging installation by ensuring sufficient power is being supplied to the site and that the necessary infrastructure is in place to safely manage the increased load (i.e., conductors, panels, trenching).

With this program, locations across NY will be able to install EV charging at their site without having to compromise based on their available power. . Sites will now be able to upgrade their location’s capacity for EV charging at a dramatically reduced cost

— in some cases over \$11,000 per Level 2 port or \$100,000 per DCFC. This program is stackable with other EVSE rebates that provide funding for the charging stations themselves (i.e., NYSERDA Charge Ready NY).

How the **funding** breaks down

Any location within the service area of the utilities listed below that is not a single-family home can apply for the EV make-ready program. Since the state funding provided by NYPSC has been divided amongst these regional utilities, the specific “make-ready” program you can apply for depends on which utility you fall under. But the breakdown of the amount you can save remains the same.
