Shortly before Christi and I returned to Phoenix in 2001, she was diagnosed with a benign tumor in her neck. When the doctor in Greeley, Colorado, learned we were moving to Phoenix, he told us that if he had her condition, the surgeon at the Barrows Institute in Phoenix is who he would want as his surgeon (divine coincidence?). We later learned that this surgeon was internationally known and had once been specially selected to operate on a princess from Saudi Arabia.

Christi condition required two surgeries, followed by nearly 12 weeks of wearing a neck brace.

Financially it was not the best time for us to go through something like that. We had just moved and brought debt with us, Thomas and Robin were six and seven years old, and Christi was now unable to work.

Fortunately, insurance covered most of the hundreds of thousands of medical fees (no, that is not a typo). What was not covered by insurance, the Presbyterian Board of Pensions Assistance Program did.

The regular meeting of the Session was called to order at 6:40 p.m. in the basement of the Randall Presbyterian Church by Moderator Reverend Michael Hartwell, who opened the meeting with prayer. Chris Magee joined the meeting via Zoom. A quick check in was also done to see how everyone was doing and any prayer concern updates.

<u>Approval of Minutes:</u> Motion to approve the September 15, 2021 Session Meeting minutes was made by Jake Farrow, seconded by Michael Lashinski. Motion carried.

<u>Approval of Treasurer's Report:</u> Summary of the September 2021 Balance Sheet – Current Total Assets: \$162,339.06 (Checking: \$5,781.00, Savings: \$156,558.06). Motion to approve the September Treasurer reports was made by Christi Hartwell, seconded by Jake Farrow. Motion carried.

- <u>Church Rolls and Register Report</u>: Phyllis C. Hoffman (member) passed away on Thursday, September 30, 2021. A memorial service was held on Monday, October 4, 2021 at Randall Presbyterian Church with the Reverend Michael Hartwell officiating. Interment service was held at Randall City Cemetery, Randall, Minnesota.
- <u>Worship/Membership/Mission Report:</u> Outdoor in-person worship continues, weather permitting, with an average of 35 attending. COVID-19 protocols have been relaxed for those fully vaccinated and for outdoor activities. Online worship will continue.

Communion was served on October 3, 2021

68 members; death of Phyllis C. Hoffman, September 30, 2021.

Monthly church mission is the Morrison County Food Shelf and the weekly church mission is Meals on Wheels.

- **Fellowship:** Morrison County Food Shelf on September 30, 2021 with four members from church volunteering. The family game and picluck on September 26 was a hit! Thank you to all who helped make it successful.
- Christian Education Report: Sunday School started on October 10, there were thirteen children in attendance. Ages ranged from 2 11. Discussion and ideas for the Christmas pageant planned for December 19 have started.
- <u>Building/Maintenance Report</u>: There are still issues with periodic water in the basement. Michael Lashinski will call Ballou Plumbing and Heating to schedule a furnace check.

- <u>Presbytery:</u> Terry Coffin attended a Special Presbytery meeting on September 27 at First Presbyterian Church in Willmar. The meeting was called for the purpose of examining for ordination candidate Laura Messer, newly called pastor for First Presbyterian Church in Silver Lake.
- Correspondence: Received a service evaluation from EEI.
- <u>Deacon's Report:</u> Nothing to report.
 - Motion to approve the committee reports as received was made by Michael Lashinski, seconded by Chris Magee. Motion carried.

Old Business:

- a. Officer training pended util COVID-19 restrictions have been fully lifted and it is safer to gather.
- b. Morrison County Food Shelf only three volunteers are needed at this time until restrictions are lifted. October 28, 2021 will be our next night for volunteering. Everyone is invited to volunteer at the Food Shelf. Starting in October the new hours to work will be 4:30 p.m. to 7:00 p.m. Please contact Geri McLennan or Terry Coffin if you are interested.
- c. Church Mutual policy change: session reviewed three alternates for policy coverage changes to the current plan to reduce the significant increase for November 1, 2021. Session chose the option to increase the deductible from \$1,000.00 to \$2,500.00 and to change the coinsurance from 100% to 90%. This produced an approximate annual premium savings of \$444.00. Starting November 1, 2021, the deductible will be \$2,500.00, the coinsurance will be 90%. Estimated annual premium to be \$4,967.90. Waiting on final numbers from Church Mutual.
- d. Board of Pension agreement was submitted on October 1, 2021 with no changes.
- f. Fall clean-up to be determined

New Business:

- a. COVID-19/Post COVID: At this time, we will continue with our current mask policy while indoors, which states recommended but not required. We will continue to monitor the COVID risk and if things worsen, we will need to reconsider changes to our policy.
- b. No deletions to the membership will be made to the Rolls and Register due to COVID-19, except for noting deaths in 2021.
- c. Appointed to the 2022 Budget committee are: Jake Farrow, Sue Klooster-Fenske and Pastor Michael Hartwell. A review of the budget categories will be assessed for changes.
- d. With the dropping temperatures, worship will now be indoors. Pastor Michael is interested in moving to livestreaming instead of pre-recorded online services. Extra help will be needed to assist with the monitoring of the camera, computer and other equipment for live-streaming. Additional equipment may be needed in the future.
- e. Kari Magee and Mary Skoog received a letter from Dr. S. G. Knight regarding "Coins for a Cause" donations. Motion to donate the balance of session designated funds to this cause was made by Michael Lashinski, seconded by Christi Hartwell. A notice will also go out to the congregation for any monetary donations they wish to make.

Motion to adjourn the meeting was made by Michael Lashinski, seconded by Jake Farrow. Motion carried.

The meeting adjourned at 7:58 p.m. followed by prayers for the people and the Lord's Prayer led by Reverend Michael Hartwell.
