Elder Board Report

Semi-Annual Reports July 1, 2021 – December 31, 2021

It would seem that a new designation of periods of time before and time after a major historic event will join "BC and AD" and other landmark events. That will be "BC and AC"; (B)efore COVID-19 and (A)fter COVID-19. This may seem to be an odd way to start an Elder Board report, but we cannot overestimate the amount of time, worry, discussion and decisions that your Elder Board has experienced dealing with this horrible virus and its effects, real or potential, on our church family. Last summer, the world seemed to be breathing much easier (literally and figuratively) with expectations that the large and growing vaccination rates would overpower the virus and we would see it reduced to a manageable level, if not fade into history. Booster shots became available in August and that really seemed to be the last, necessary step to substantially reduce fears and illness. Then the Delta variant came along...

The Elder Board looked to national, state, and local authorities for guidance on best practices on keeping our worshippers safe but came to the decision that God's people need the ability to worship, pray and fellowship in person. We decided that worship will not be canceled. Modifications have been made to our services as necessary including fill-in preachers who have preached wonderful messages as they have been led by the Spirit. We are seeing a growing numbers of worshipers in church and that is great. While we believe that attending services in person is the best way to worship, we continue streaming services because our number one desire is to bring the Gospel to whomever and however possible.

With the new fiscal year, the Elder Board sought a renewed vision for Grace Fellowship Church under our new mission statement "Adoring, Obeying and Proclaiming Jesus Together". An emphasis in our meetings to be led by the Holy Spirit has been instituted. The Elders completed a rather extensive questionnaire in which we compiled individual scores and shared thoughts on what our church, staff and elders are doing well and what needs improvement. The results have been the basis of discussions and direction for Elder Board and church priorities.

During these six months, there have been numerous signs that our church family is more than ready to break out of fears, sheltering and doldrums of the previous one-and-one-half years. These include:

- -The start of a new ministry- Caring Companions for widows/adult singles in our congregation.
- -The fall kickoff of the Women's Ministry special events.
- -A very successful "Trunk or Treat" outreach event in our parking lot after God cleared the clouds.
- -A Saturday morning breakfast meeting of team leaders and those active in various ministries in which leaders reported their groups' duties, needs and plans. Pastor Kyle encouraged all to focus on the mission statement as they make plans for the future.
- -New volunteers are taking part in numerous ministries that make our worship and church family life so rich and fruitful, including discipleship, worship, local missions, hospitality and other outreaches.
- -Regular tithes and offerings have far more than matched needs with a surplus that is available to further God's kingdom.

-The end of a very successful fund raising and match program resulting in reconstruction of the Minnesota parking lot, repairs to sections of sidewalks, replacement of the office steps, replacement of the south air conditioning unit, repairs to the radiator hot water lines, replacement and upgrades to the sanctuary projection system, upgrades to our lighting with LED spotlights and the list goes on. All these repairs and improvements have been paid and we have \$15,000 left over to help pay for maintenance to the parsonage and repairs to church basement footing tile.

Yes, there are many signs that God is good and gracious to Grace Fellowship; that our church family loves Jesus and follows his commands with spirited worship, loving fellowship and acts of love and service to others. Some acts are open and visible, but many are behind the scenes with only God and a few others seeing. "They will know we are Christians by our love, by our love."

COVID-19 continues to affect our church life despite our determination to return to a normal church life. We have not observed the three-fold communion for some time and people are missing that special service. It is hoped that we can hold this service around Easter. It has also been a long time since we have held the popular, church-wide fellowship meals, most of them held at the Grady farm. It is hoped that we can again gather for fun fellowship events soon.

People have been asking about progress in finding and hiring an associate pastor of family life. This will happen when God determines that the time is right, and it appears that this is not the right time. The search committee communicated this position to multiple seminaries and job sites and have had only a few responses, none of which seemed to the search committee to be a good fit. Pastor Kyle has said that there are many openings for associate pastors and few candidates across the country. It was said from the beginning of the discussion to hire the right candidate; that we are not just to fill a position but answer a need. This will happen when God determines. In the meantime, adjustments have been made to schedules and volunteers have stepped forward to make good things happen in discipleship and worship. For example, David Pick, Dave Lux and Ron Weimer have given spirit-filled messages from the pulpit when Pastor Kyle could not be present.

Grace Fellowship Church has received many amazing blessings during the first six months of the current fiscal year. These blessings would be humbling and inspiring during BC (before COVID) times, but with the church operating in this AC period when a new "normal" is being created day-by-day, the grace of God and generosity of our family is simply mind-blowing. Our worship services seem to get more and more "fragrant" in the Spirit with inspiring music and sermons in which Pastor Kyle draws us closer to Christ and the Gospel. After a recent, wintery Sunday on which we had services when many churches did not, a man said "I do not know who made the decision to have church but thank them. I needed to be in church on Sunday". It was a "God moment".

Because of illness, travels and busy schedules, it has been difficult for the Elder Board to meet on a fixed schedule. It meets on an approximate monthly basis, in person or by Zoom. Many discussions are carried out by email. The Elder Board is committed to being open and accessible to our church family. Of course, there are matters that must remain private or are premature to share with the Grace family, but the Elder Board wants to be approached with questions and answers given. We want the church family to be aware of current issues and future plans. It is an honor yet humbling to serve God and Grace Fellowship Church.

Annual Meeting Minutes

July 25, 2021 July 1, 2021 – December 31, 2021

Members attending: 43

Pastor Kyle opened the annual meeting in prayer at 8:45am.

Carl Meyer started the meeting with a motion from Terry Kuntz to approve the minutes of last year. David Pick seconded. Motion carried.

Recap of the activities of the last year:

- 1. Challenging year because of COVID.
- 2. Determining how and when to open the church again and how it was to be done to protect all of the congregation.
- 3. We were able to have the Bread and Cup five times. We were unable to have 3-fold communion because of safety with COVIC.
- 4. Church approved of the Jordan Baptist Church to use our facilities on Sunday afternoons for their worship service. Their attendance is averaging 90 people and several of the children and youth are attending our children/youth activities.

Parking lot and air conditioning updates:

Jim Grady presented the update and with talking to the city and all the regulations, he feels the best for us at this time is to asphalt and not cement. The cost is significantly lower than was presented last time because of the asphalt. The bid of approximately totals \$70,000. This includes: asphalt with additional ½" thickness, curb stops (35 @ \$44), stripping the parking lots, surveying, some hidden cost which always happens, repairing the steps and sidewalks and widening the drives to the Williston parking lot and replacing the air conditioning on the North side. We are able to put the new air conditioning on the old spot so that saves us a lot of money.

Some of the questions asked:

What is the life span of the asphalt? In 4-5 years we will have to reseal and strip the parking lot. We hope that if maintain properly it should last at lease 15 years if not more.

What is the savings by using asphalt vs cement? We will be saving between \$60,000 to \$70,000.

Is the elder board unified in using asphalt and replacing the air conditioning? Whenever the elder board bring items to the congregation it is always unified.

Can we add more parking to the Williston lot? We do not own the house that is connected to the parking lot but if it ever comes up for sale we would be interested in purchasing. The point section is owned by the city. We maintain if for them.

Russ Davis shared that there has been a matching gift of \$30,000 for the above projects and that there is already \$14,000 pledge for these projects. We ask that if you are willing to pledge for the parking lot/air conditioner that it be turned in on or before October 1, 2021. Reminder that this would be over and above your normal tithe.

Associate Pastor:

Pastor Kyle shared the biblical reasons that are needed for change in how we are teaching our children and youth. The children and youth are facing some major problems with social media etc.

Some of the changes needed are:

- 1. Believe that the scriptures are true.
- 2. Kids have challenges and we need to prepare them for these challenges in our home and churches.
 - 3. Reform our church to be more biblical.
- 4. Integrate our ministries so that we have close relationships with grandparents, parents and the church family.

Pastor Kyle shared several scripture passages for us so that we will be a more biblical family.

A search team has been started. The people who have already been contacted and have said they would participate are: Pastor Kyle and Esly, Matthew and Athena, Elaine Clark and Russ Davis. There will be more added. Would like at least 8 on the team.

Pastor Kyle can not do it all to have a successful children/youth ministry.

What would the salary be? Approx. \$45,000/year including the benefits. We have been making a monthly payment for our mortgage and with the savings of the parking lot we should be able to financially support this position as well as each of us increasing our tithe \$5/week.

The vote is not to add this position but for us to begin the search.

Financial update:

We ended our fiscal year in the black by \$27,031. We were given two budgets this year. One without adding an associate pastor and one with an associate pastor. The difference between the two is about \$5.00 per week. The budget is in the packet so if you have any questions, please contact Russ Davis and he will gladly explain the two.

New Elder:

The elder board have asked Matthew Grady to become an elder for a 3-year term and he has said yes. Elders are excited to have a young person on the board because they are getting a little older!!!

The ballots were handed out and turned in after each subject.

Don Penn made the motion to accept all that was discussed and the meeting to be adjourned. 2nd by Judy Banes. Motion carried.

The ballots were counted and the outcome for all was a YES!!

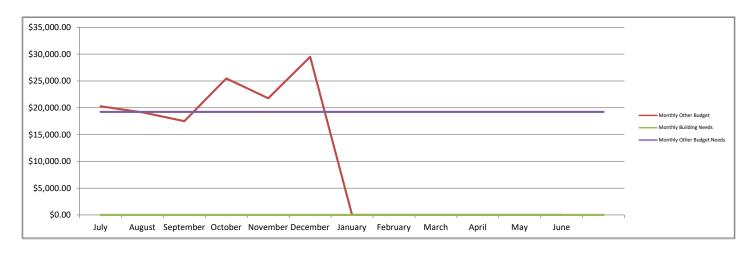

Treasurer's Report

Semi-Annual Reports July 1, 2021 – December 31, 2021

Financial Summary:

As of December 31, we have \$149,414 in our Checking and savings accounts. Of that total, \$93,818 is at Community Bank in Waterloo and \$55,596 is at GBIF in Winona Lake, Indiana. All bills are paid and our liabilities balance is \$48,905. (See the Balance Sheet Report)

(From our P & L Budget Report) Our Budget for the first half of our fiscal year was \$115,466. We actually took in \$132,149 or \$16,683 more than budget.

Our budged expenses for the same period were \$103,983 which is \$13,055 LESS than budget so at 6 months we have received \$29,739 more than we have spent. Praise the Lord!

Not only have we given to our general budget more than projected but we also completed our matching funds project, all in the same year! Thank you for your faithful and sacrificial giving during these COVID times.

Matching Fund Project

At the start of July 1, we had already raised \$14,022. Between July 1 and Dec 31 we received \$59,329. This allowed us to not only meet our goal of \$75,281 but surpassed it by \$1,070!

This money allowed us to pay for the complete Minnesota parking lot project, The Air conditioner and wiring on the south side of the church, , new steps to the office, removal of walnut trees from our Williston parking lot and 4 sanctuary spot lights. These expenses totaled \$59,556. That leaves us with a balance of \$16,795 which will be used for needed repairs and appliances in the parsonage and some foundation work under the Pastors office.

Other Notables:

This fall Pastor Kyle purchased a home so moved out of the parsonage so at this time we are receiving no income from the parsonage.

We changed insurance companies this past fall. Our monthly rates dropped from \$1,138 with Brotherhood Mutual to \$844 with Grinnell Mutual.

In October Russ Davis stepped down from the Treasurer's position and transferred the responsibility to Brad Morris.

As we look at this past ½ year from a financial perspective we are doing VERY WELL but when we take a closer look we see that the majority of our expenses were to fix and update our building. Our budget was not met and that means that most of our ministry goals were not met. We need to be more "On Purpose" about doing ministry. Reaching the lost. Equipping the saints. Let's pray that the 2nd half of our fiscal year sees us more actively working and reaping Heavenly rewards that honor our Lord.

Finances: Grace Fellowship Church remains in solid financial condition. See the Treasurers report for assets and liabilities.

Minnesota parking lot and concrete improvements: The Minnesota parking lot was completely redone and it looks fantastic! Many barriers were strategically placed around the perimeter to deter trucks from being in the lot. The entrance on the Minnesota side was enlarged. The lines were painted courtesy of Dean Weikert. The sidewalk on the Minnesota side closest to the church was repaired as well. We also have new steps to the office. We have been wanting to complete these for quite some time and it is nice to see that happen. Special thanks to Jim Grady for directing this project. This along with the south side air conditioner replacement were covered financially by a matching fund of \$30,000 (\$60,000 total).

South side air conditioner replacement: A new unit was installed this fall by Young's Plumbing & Heating. In addition, Young's repaired the water heating system, replacing several valves. The funds were again covered with the matching fund. Special thanks to Dick Jensen for coordinating all the details of this project.

Removal of two large walnut trees: Two rather bothersome walnut trees were removed from the side of the Williston parking lot. The trees would frequently lose limbs in addition to dropping walnuts that needed cleaned up. This was done for a cost of \$1900.00. Rick Johnson made the contacts for this.

Servant Keeper Membership and Financials Program: This program was purchased to replace a program that we had been using for the past fifteen years. The older system required many patches. This will keep the records in one place.

Washing & waxing floors: The large and small fellowship halls were cleaned and waxed. It had been some time since they had been done. The nursery and welcome center carpets were cleaned as well. Thanks to Jean Camarata for making those arrangements.

Stage spotlight replacement: Eight old stage spotlights were replaced with energy saving LED spot lights.

Insurance carrier: We changed insurance carrier to Black Hawk Grinnell Insurance. This results in a savings of \$300.00 per month or approximately \$3,600.00 per year.

It had long been on the heart of Cindy Lear and Vivian Weimer to recognize and minister in some way to the growing number of widows/adult singles in our congregation. After praying faithfully for God's direction to this desire we reached out to invite a Sunday morning class opportunity for this group in our congregation. We began on Sunday, October 24 and continued meeting through December 12 on Sunday morning with 8-10 faithful attendees.

We were able to provide free to our church/class, and use the book, *Free to Lean: Making peace with your Lopsided Life* by Jocelyn Falck Green. This proved to be pertinent to the lives of those who no longer fit into the 'couple' or nuclear family model and were privileged to have the author speak to our class and do a book signing at the end of October. Our class time focus has been to mutually support one another with scripture, prayer and discussion, driven by the needs expressed within the class rather than the agenda of the leaders.

Besides the priority of supporting, encouraging and ministering to each other's needs, we desire to provide service opportunities and minister to our larger church family and community.

In November, we had a pasta freezer meal workday where we made homemade pasta freezer dishes for over 20 adult singles, widows/widowers. Care Commission members, Diane and Don McGriff were able to get in on the blessings delivering these meals to those who are not mobile or have not made it back to in-person services yet.

Also, with the financial help of the Care Commission, we were able to gift each person in the class with the book, *Grieving the Loss of a Loved One, A Devotional of Comfort as You Mourn* by Kathe Wunnenberg. We continue to hear from those using it how it has blessed their lives.

Men's Ministry Report

Our men will see a need and take care of it personally or share it with someone or several others and then "Get it done"! We are working together, encouraging each other, enjoying fellowship. We are brothers..... in Christ.

We look forward to the time we can once again sponsor events for our men and our church. It's not too far away but until then we are encouraged by the working of the Spirit within our men at Grace Fellowship.

Partners In Education (Lowell Elementary) Report

Both the school roof collapse in February 2019 and the Covid 19 pandemic of 2020 and 2021 affected our partnership with Lowell Elementary. But things are improving!

After nearly three years of classes in a Cedar Falls location, the students and staff are back across the street from Grace Fellowship! Over Winter Break carpeting, furniture, library books, and hundreds of cartons of classroom supplies were moved to the brand-new building! The students were able to walk into their new school on January 3rd. They adjusted quickly, and of course the adults did, too. There will be an open house for the public tentatively set for March 24. Everyone from GFC should try to go – especially if you taught there or attended as a child!

Once again, we were able to provide the teachers and other staff members with a pizza lunch the day before school started. This coming August we will be able to have them come to the church for a more complete meal and perhaps some entertainment. At this time, we donate school supplies and backpacks for the students as well as copy paper and other items for the teachers and office personnel.

It took a while to obtain pen pal journals. There was no problem getting GFC folks signed up to be their writing buddies! This year we have the fourth grade instead of second. Many of the kids are behind grade level in their writing skills, mainly due to the pandemic. Others are more fluent in a different language. Most enjoy having someone to write to. Last year many of us were able to meet our pals near the end of the school year. That will be easier now that they can walk down the street to GFC! We will provide treats and entertainment. We plan to have gifts for each to open.

We did not do Christmas gifts this year, but each child gets a bag of small items and snacks during their birthday month. We include summer birthdays also.

Another heart-warming activity is Adopt-A-Family at Christmas. This year our family members were recent immigrants from Micronesia. The mother works nights at Panera, two little ones attend Elementary School, and the dad has some serious health problems. The 15-year-old girl was waiting for papers from Hawai'i, where they had lived since fleeing Micronesia. This deserving family was grateful for the laundry supplies, school clothes, toys, and many other gifts.

All of Lowell's partners are asked to collect HyVee receipts, Box Tops, and Milk Moola.

New this year are Cougar Carts prizes. Students receive coupons for exemplary behavior. Many of us are cleaning out drawers, cupboards, and closets and donating puzzles, games, toys, decorative items, even advertising pens and pencils that are clean and in good shape. The students often choose something that they can give a family member, not keep for themselves!

During the next six months I will continue to attend monthly meetings with (some of) the other Partners. Anyone is welcome to go with me.

We will provide a special treat for Shining Stars (12 students) in April and in May during their regular lunch period.

We will also provide healthy snacks for 3rd through 5th graders while they take ISAP (state) tests in April.

Lowell School is grateful for all the winter clothing. They are well-equipped for the rest of this winter. There is always a need for school-appropriate clothes sizes 4 through 18.

Please continue for pray. In Acts 1:8b Jesus tells his followers ". . . you will be my witnesses, telling people about me everywhere – in Jerusalem, throughout Judea, in Samaria, and to the ends of the earth."

Lowell School is part of our Jerusalem mission.
