## **Articles of Incorporation Changes**

#### **Article VII. Amendments**

**Presently reads:** The Articles of the Corporation may be amended upon recommendation of the Executive Committee at an Annual or Semi-Annual Meeting of the Marion Baptist Association, or related called meeting of the Association by a two-thirds affirmative vote of the Messengers present, voting, duly elected, and duly registered, provided that notice of such change shall have been sent to member churches at least thirty days prior to such meeting.

**Proposed change:** The Articles of the Corporation may be amended upon recommendation of the Executive Committee at an Annual or Semi-Annual Meeting of the Marion Baptist Association, or related called meeting of the Association by a two-thirds affirmative vote of the Messengers present, voting, duly elected, and duly registered, provided that notice of such change shall have been sent to member churches at least thirty days prior to such meeting. **Messengers will be considered present in-person or via electronic means as provided in the bylaws.** 

## **Article VIII. Annual and Special Meetings**

**Presently reads:** Annual, Semi-Annual and special called meetings of the Association shall be held as provided in the Bylaws. The Assembly of duly elected and registered Messengers at such meetings shall constitute the Association-in-session, which shall have ultimate authority.

**Proposed change:** Annual, Semi-Annual and special called meetings of the Association shall be held as provided in the Bylaws. The Assembly of duly elected and registered Messengers at such meetings shall constitute the Association-in-session, which shall have ultimate authority.

## **Bylaw Changes**

#### Artilce IV. B. Admission of Churches and Missions

**Presently reads:** Churches or missions desiring membership in the Association shall present a written request. The request must be received at least sixty days prior to a Semi-Annual or Annual Meeting in order for it to be considered at that meeting. The Moderator shall appoint an ad hoc credentials committee to review requests for admission and make appropriate recommendations to the Executive Committee: Requesting churches must provide a completed membership application. The request will be referred to the Executive Committee who shall...

- Assist churches in preparation of their application if requested
- Review and approve all documents
- Interview the pastor and church leaders
- Present a written recommendation at the Semi-Annual or Annual Meeting in which action is to be taken
- An affirmative vote of at least two-thirds of those present and voting in such meeting shall be required to approve a church or mission for admission to the Association.

The request must be received at least sixty days prior to an Semi-Annual or Annual Meeting in order for it to be considered at that meeting. - An affirmative vote of at least two-thirds of those present and voting in

such meeting shall be required to approve a church or mission for admission to the Association.

#### Article IV.D. Dismissal of Churches

## **Presently reads:**

Action by the Association must be approved by two-thirds of the Messengers present and voting in the Annual or Semi-Annual Meeting.

#### Article V.E.

**Presently reads:** The Nominating Committee shall present nominees for office at the Semi-Annual or Annual Meeting. Each Officer and/or Director shall be elected to serve one association Year (October 1- September 30) unless otherwise provided for in the Procedures Manual.

**Proposed changes:** The Nominating Committee shall present nominees for office at an the Semi-Annual or Annual Meeting. Unfilled or vacated positions following this meeting may be filled at subsequent Executive Committee Meeting. Each Officer and/or Director shall be elected to serve one association Year (October 1-September 30) unless otherwise provided for in the Procedures Manual.

## **Article VI A. Meetings**

Presently reads: The Association in regular or called session shall be composed of all Messengers duly elected and certified in writing by their respective churches. The Association-in-Session shall have ultimate authority in the Association. Churches are requested to send their list of elected Messengers to the Clerk prior to the meetings. In order to vote in these meetings, Messengers must register with the Clerk before the point at which Messengers are to be approved. Each church shall be entitled to a minimum of three (3) messengers and two (2) additional messengers for every twenty-five (25) resident members over the first fifty (SO) members except that no church shall be entitled to more than fifteen (15) messengers. (Example: 75 resident members entitles 5 messengers, 100 resident members entitles 7 messengers, 125 resident members entitles 9 messengers, etc. with a maximum of 15 messengers from any given church).

**Proposed change:** The Association in regular or called session shall be composed of all Messengers duly elected and certified in writing by their respective churches. The Association-in-Session shall have ultimate authority in the Association. Churches are requested to send their list of elected Messengers to the Clerk prior to the meetings. In order to vote in these meetings, Messengers must register with the Clerk before the point at which Messengers are to be approved. Each church shall be entitled to a minimum of three (3) messengers and two (2) additional messengers for every twenty-five (25) resident members over the first fifty (SO) members except that no church shall be entitled to more than fifteen (15) messengers. (Example: 75 resident members entitles 5 messengers, 100 resident members entitles 7 messengers, 125 resident members entitles 9 messengers, etc. with a maximum of 15 messengers from any given church). **Messengers may be considered to be present and able to vote in-person or via electronic means as approved by the Administrative Team.** 

## **Article VI. C. The Semi-Annual Meeting**

**Presently reads:** The Association shall meet in the spring for its Semi-Annual Meeting at such time and place determined by the Administrative Team. The purpose of this meeting shall be to elect officials for the coming year; to promote the work of the Association; to conduct pertinent business; and to enjoy Christian fellowship and worship.

#### **Article VI. E. Quorum**

No business of a legally binding nature may be conducted without at least:

- 15 members of the Executive Committee present for an Executive Committee meeting
- 50 qualified messengers present for any regularly scheduled meeting of the Association in-Session

**Proposed changes:** Duly elected messengers (for an annual meeting) or Executive Committee members (for an Executive Committee meeting) present either in-person or via Administrative Committee approved electronic means shall constitute a quorum.

#### **Article VI. H. Minutes**

**Presently reads:** The Minutes of the Association Annual, Semi-Annual and Executive Committee meetings are to be recorded by the Clerk. Such Minutes are to be reviewed and approved at the next scheduled meeting.

#### **Article VII. Executive Committee**
