In August we stopped paying for someone to check the church because the security cameras and burglar alarm system were installed. At year end we have saved 750. The Burglar Alarm system cost 825, which included installation and 225 a year for the service. As of March 2023, We will have saved enough to completely pay for the system. We will then save money each month. Another interesting note, not one person has accidentally tripped the alarm system..... not yet.

For the year to date we have taken in \$27,522 more than we have spent! This includes all spending and income, not just budget. Just 4 years ago, Dec 31, 2018 we had lost \$24,000 in our first 6 months.

NOTE: We will be moving 60,000 to Grace Financial (previously GBIF) shortly after the first of the year

The Lord has put us in a very unbelievable financial position. Our attitude should be "Lord, how do you want us to use YOUR money? Open our eyes and show us where you want us to go so we don't get in your way!" Praise the Lord for His goodness.

Business Team Report

Semi-Annual Report July 1, 2022 – December 31, 2022

As the new chairman of the business team I want to personally thank Jim Murray for the faithful work he has done over the years as the business team chairman. I'm now seeing the work he has done and will be hard shoes to fill. I also want to thank Jean Davis for her excellent secretary recording. You don't want to say anything out of line or it will be in the minutes. Your business team is responsible for the church building and the finances of the church. The finance report will be given by Brad Morris and Tracy Keller. I will give the report on actions discussed and acted on during the past six months.

We have been trying to figure out why we get a sewer smell down by the water fountains. Rick Johnson has been checking into this and has gone into the wall behind the fountains and discovered some problems. We still do not know how to fix it, but Rick is on it as I write this.

We have discussed at length about our streaming of the church services and when Brad checks it here at the church it is working well but we hear from people that are listening that there are problems. This is and will be an ongoing problem until something pops out in front of us that here's the problem. Rest assured that we continually are trying to improve it.

The wall in the parsonage has been fixed by an outside contractor. It was bowing in and the put steel strips on the wall to guarantee it would not keep getting worse. Then under Russ Davis direction some of your business team members put in new paneling on that same wall and fixed up the floor and painted it. We have had good rains since then but there has not been any water leak into the basement.

The business team voted to go with Hawkeye Systems for the church's security system. It has been a work in progress and Brad Morris is handling all of it. He has spent countless hours working with Hawkeye on this project. As of right now it is working fine. There is an alarm system on all the doors that automatically arm at night and disarm in the morning. Also, they have installed cameras all around the church so that a few of us can monitor the activities going on outside the church building. The office can monitor all the activity all the time. So smile when you are in church because you might be on camera.

The church purchased a new John Deere lawn mower to replace the old broken-down rider. A church member stepped up to the plate and purchased the mower for about \$6,000.00. A snowblower also came with it.

Dick Jensen has done a detailed church handbook that details all of the church building and how everything works. It is quite lengthy and a valuable resource for taking care of the facilities.

In August our former janitor Janice retired, and we hired Teresa Livingston as our new janitorial person. She works eight hours a week and more if needed. She has been doing an excellent job also. If you see her at church sometime say hello and thank her for her great work.

We also had a church work night and twenty or so people came in and mopped the basement floors and then wiped down all the pews and furnishings in the sanctuary.

Mike Christian has done quite a bit of work on the church van. New brakes, fixing running boards etc.

The parking lot on the Williston side of the church had some attention to it. We had all the cracks filled with tar to help keep the weeds out and also to get us a couple more years before we need to resurface it. The cost was around \$4,000.00.

Signs were put up in the kitchen to inform people not to leave any perishable food in the refrigerators more than a day or two. If left longer than that it will be thrown out. Be sure to clean up behind you and make sure you wash all utensils that are used.

A new women's ministry room was set up down the steps and to the left of the Minnesota door. Russ Davis cleaned it out and put carpet squares down and fixed the light to the closet. Welcome to your new home ladies.

It was brought to the business team's attention that the church scholarship needed to be addressed. We have been giving youth church members a \$1,000.00 scholarship each year they attended a Christian college. We change that to \$2,000.00 a year.

It was brought to the business team that the Elders were recommending that Gabby Skiles be brought on as paid staff to help with the youth responsibility. There were many questions, and a job description was given. We voted 100 percent in favor.

The mission team requested that we support Austin and Lori Taylor \$3,000.00 per year for their ministry with Cru.
