## Lent 2023 Walking to Jerusalem with Jesus A Study of Mark 8:22-10:52

In the 8th chapter, the Gospel of Mark places Jesus in Bethsaida, just north of the Sea of Galilee. From there Jesus begins his journey to Jerusalem; his journey to the cross.

I find Mark 8:27-10:52 to be one of the most exciting, demanding, revealing, and engaging sections of the Bible. This year during Lent, I invite you to walk with Jesus to Jerusalem and the cross.

The section begins with Jesus healing a blind man at Bethsaida, which is near Caesarea Philippi, Mark 8:22-26. It concludes with Jesus giving sight to Bartimaeus (Mark 10:46-52) after leaving Jericho, just outside of Jerusalem. Between these two healings, Jesus foretells his death three times, and continues to teach what it means to follows Jesus. Yet the disciples never fully understand what is happening. Instead they continue seek their own glory.

The section leads us right to Palm Sunday. As we study these passages, we are called to remember our own human frailties that prepares us for the full reconciliation with Christ that is promised in the resurrection.

#### Message from Michael

## The church does not have membership dues.

One of my doctor of ministry instructors was Diana Butler Bass, a well known Christian author and speaker. She told the class of an experience at her home church in Washington D.C.. It is a downtown church, and the area has many homeless and out-of-luck people. Many of these people were repeatedly invited to join the church in worship, but they never really felt like they belong.

So, the church decided to create a new service where the poor and homeless would feel welcome. In many ways it was a typical Episcopal service, except no offering was collected. The church thought it would be inappropriate expect of even ask *these* guest to contribute.

However, after a few months the homeless members approached the leadership and insisted their service should include a traditional offering. They were now members of the church, and they wanted to contribute to the life and ministry of the congregation.

That story appeared in the book Diane Butler Bass published the next year, which included this paragraph.

Daniel, a member of the traditional congregation, recalled how moved he was the first time he acted as an usher at the homeless services; "As the plate passed down the rows, I watched poor people turn their pockets inside out an throw loose change and crumpled dollars in the offering. I almost cried. I learned more about giving that morning than in a thousand sermons."

As Christians, we believe that everything we are and all that we have are our gifts from God. We express our thanks for these gifts by joyfully returning to God a portion of those gifts. It is a practice that goes back to the time of Adam and Eve, when Cain and Abel brought their offerings to God.

We continue to believe the practice of offering our gifts is a spiritual discipline, and a necessity to continue the ministry of Jesus Christ at Randall Presbyterian Church. However, our offerings should never be considered membership dues or some kind of tax. Unfortunately, Per Capita is often seen as just that.

Per Capita is a reminder that we are a connectional church. United with Presbyterians throughout the country, the Per Capita is the primary source of funding for the Office of the General Assembly, and supports the work of the Presbytery and Synod. Each church contributes based on its membership. It is a financial obligation the church has just as the church is obligated to pay utilities or salaries.

In the past, like many churches, we asked members to make a special contribution to cover the expense to the church. Unfortunately, it has become clear to me that many members do see this as membership dues.

Therefore, this year, we are not campaigning members to make that additional donation, and the session is seeing our Per Capita as just another expense—like utilities.

Personally, my desire is that none of your contributions are seen as dues, taxes or merely necessary obligations. I hope your offerings are joyful thanksgiving to God, and a commitment to continue the life and ministry of Randall Presbyterian Church.
